#### PRESIDENT'S REPORT

Season 2019 saw major change with a new Executive and a new age group structure. With registrations in excess of 420 players, the early goal was to ensure we had enough hands on deck to take on the challenges of a new committee, along with an entirely new grading system.

From the outset the group of fearless leaders recognised that although all very different personalities from varying professional backgrounds we all had a clear idea on which direction the club should be headed.

The focus was to set clear benchmarks for coaches, support staff and parent groups to ensure the most important members of the club, our players, were provided a fun, safe, and well organised club to be proud of being a part of.

The question is how did we go?

Based on feedback received throughout the year and the obstacles faced, there are certainly areas to improve, but on the whole we have had a successful year. As a group of (some first year) volunteers we made a commitment to work together to make Williamstown Juniors a warm and inviting community club, welcome to any suggestions of improvement, especially when those suggestions come with an offer to help bring said ideas and suggestions to life.

#### **Game Day Volunteers**

Sunday Mornings from 7 am was a flurry of activity at Bayside Oval. Over the course of the day more than 100 parent volunteers will help in excess of 240 players enjoy the great game of AFL – and this is for home games only! There are still 60 parents ferrying 150 plus players to away grounds and taking up positions for their games.

Match day and training night volunteers make it possible for our young boys and girls to be able to play each Sunday. I would like to personally thank each Parent, Grandparent or sibling that volunteered his or her time this season. Coaches, Assistant Coaches and Team Managers don't simply turn up each Sunday. There will have been several conversations amongst the coaching/Team mangers but also phone calls, text, messages and email correspondence from parents and the committee to fit into the family and work schedule. Thank you for your contribution to the club and your community.

To all the trainers that continue to ensure injured players and their families are well looked after and

informed, thank you. Finally, to the parents that consistently make themselves available, whether you are umpiring, water person, scorer or bringing along the oranges and snakes, your contribution is so valued.

2020 will bring significant growth and with such growth will come more responsibility. I urge any Parents or Grandparents that have the passion for community and see an area of need within the club, to please put your hand up to assist. All help is greatly appreciated, even if meetings are not your thing, there are many portfolios such as Social Media, Canteen Coordinator, Team Manager Coordinator, Marketing and Merchandise, that require attention and the responsibility falls on the committee, some of whom have to take on more than one role if other volunteers are not forthcoming.

#### Committee

With over 400 parents involved with the club, the Committee of 11 did their best to ensure the club was well run. More volunteers in 2020 are needed, ideally the current committee would love to be able to personally identify members to take up positions and level of availability but we really do rely on people advising interest and this will allow each committee member to focus their time (especially the Executive)

on the roles they nominated for without having to manage more than 2 portfolios. As volunteers with employment and families to manage, the more parents involved in roles will allow the committee to concentrate on the many facets and time-consuming tasks to get players on the track for training and match day. Ultimately the children will be the beneficiaries of the extra help.

I wish to express my sincere thanks to the 2019 Committee.

Mark Ryan stepped in as VP as well as his role as age group coordinator U9 - 12. Mark also coached theU14 Div. 3 side. Mark was always willing to step into an MC role at events and has mastered the Q&A to keep formalities informative and palatable for attendees at functions.

It was delightful to welcome Wendy McInerney on board as Administrator/Secretary this season; Wendy has much experience in policy and procedure, which helped with the fine-tuning of the grading policy. Thank you, Wendy for jumping straight into the deep end after your retirement!

Rohan King continued the unenviable task of Treasurer this season but his efforts didn't cease with the club financials, he also (with great success) took on the role of Sponsorship engagement and played a huge role assisting with some difficult communications with the WRFL during the season. Rohan was always a willing ear to all of the committee. The club will be at a great loss as Rohan has had to stand down from any Committee role, effective immediately, due to conflict of interest with his role as Director of Loaram Constructions. Loaram, also a sponsor of WJFC, has put forward a tender to HBCC for the pavilion upgrade at Bayside Oval. Rohan, it has been a pleasure to have you on board and your unwavering commitment, support to myself, and those on the committee that had the pleasure of working with you.

Ross Vicino again ran with age group coordinator for U14 and U16 as well as overseeing all of football operations. The general committee comprised of Darren Ryan (who readily jumped on board a new Team Mangers night format and facilitated the successful evening) along with Craig O'Brien (First Aid Co-ordinator and Child Safety Officer). #### VICE PRESIDENT'S REPORT

To the Committee and Members,

Doesn't the year just fly!

This year I was keen to play a larger role at the club and found myself assisting the club in three different capacities being Vice President, Football Operations Co-ordinator U9-12's and Coach of U14 Div 3 Team. Each one of these roles came with their own set of challenges and a rolling to do list throughout the year. I was very lucky to have wonderful support and encouragement from my fellow committee members and coaches. I would like to especially like to thank Ross Vincino who has been an enormous juggernaut of energy and goodwill to all at the club and Tony Modola as Director of Coaching who also has been invaluable in plugging holes in a very large list of items to organise and co-ordinate.

I would also like to personally thank Phil Noonan, who coached alongside me in u14's, particularly with debates around grading, selection and not to mention the WRFL making divisional changes which unfortunately didn't render a great result for our teams. Phil always gave me great perspective and council and was a wonderful support on the training track facilitating an inclusive squad approach to the Div 2 & 3 teams.

From a Committee prospective our meetings been very engaging and productive where a broad range of topics have been efficiently discussed and considered with deliberate decisions made to improve our club. I took the lead on documenting some of our views in the form of a formal Age Group Selection and Grading Policy which underwent a number of drafts and iterations prior to season launch. We appreciate that by simply writing up what we think is best for the club and our kids doesn't necessarily translate on field and naturally there was some teething problems to bring the execution of the policy to life. Like most things it's a work in progress.

Mel McVeigh has been an outstanding leader to work alongside. Nothing is a fuss. Mel has approached the Presidency with a very deliberate empowering approach. She is extremely dedicated, has a great awareness of kids and family's needs and loves to have a laugh also which makes everything run without unnecessary drama. She has taken a somewhat Jonny Farnham approach being ... "Take the Pressure Down!" Mel has created a stronger community footy club - one centre on care, development, wellbeing and empathy for all kids.

To assess our stewardship as a committee I proposed a set of key measures which would form a Club Report Card on how we were delivering to the Club's Purpose. The major input for the assessment was from our Parent Player Survey. I'm pleased to present some strong improvements below for your reference:

He also provided us with a Strategic Framework to think about future initiatives to drive further sustainability and success as a community club. For the 2020 year we will look to sharpen our focus on a number of areas including our Volunteer Strategy, Sponsorship Programs, our Football Curriculum for coaches and of course the Development of our Facilities.

After some very fun nights out at the Italian Club as a family I suggested that Tony Modola might be able to talk to his old family friends (his Dad and Uncle were founding members) to see if we could hold our end of year event at their welcoming and intimate Italian clubrooms which incidentally was a movie cinema back in the day. With Dean Martin's prowess as a gun events coordinator and an awesome social subcommittee supporting we had a great Casino Night. I was MC for the night and was delighted to see our parents and sponsors kicking up their heels and having a fake flutter on the gaming tables. Thanks to all the kind donations which raised a significant sum of money to invest back

At the start of the pre-season I formed part of the Coaching Selection Sub Committee helping interview and select coaches for all the age groups for the 2018 season. The effort was well worthwhile as the calibre of coaches this year was excellent and as you can see from our feedback results translated into happy in kids and parents.

To ensure that we removed any apprehension or cumbersome obstacles from parents applying for coaching roles into the future, I restructured the Coaching Application Form moving to a more refined question set which could be completed online. I'm pleased to say that we have significant interest in our coaching roles for 2020 will by the time you read this report we will have appointed nearly all of our

From a Footy Operations perspective, the committee and club will not be the same without Ross Vincino. I would like to say a massive thank you for the contribution you have made over the years. I look forward to seeing you around the club on match days and at the many social events during the

### TREASURER'S REPORT

The 2019 season has been financially strong for the WJFC.

Season 2018 was a year of change within WJFC where a number of new initiatives and tools were injected to improve our systems, record keeping and financial management. In contrast, current season 2019 and its associated strong financial results have been underpinned by a process of consolidating the changes of last year, refining our cost measures and building our revenue beyond the primary channel of WRFL generated player fees.

The enclosed accounts provide a detailed insight into the financial performance of the club through season 2019 and to that end are self-explanatory. This report is therefore focused upon the broader initiatives introduced in season 2018 and how these have washed into season 2019 (and beyond).

1. Xero based accounts systems.

The club now sits on the Xero platform and into our second year of this initiative it is serving us very well. Our accounts are now current each month and the process of the year end annual audit has been seamless. Importantly the club will be able to transition to future treasurers with all club financial IP detailed and stored for easy access and use. 2. WJFC debit cards.

This initiative has been pivotal in season 2019 where a dedicated Debit card for our canteen management has made micro measurement of the canteen performance infinitely easier. The process of reimbursement has been significantly reduced by introducing the debit cards and this tool has significantly improved our capacity to accurately allocate club expenses to the correct cost centre.

3. Grants.

In 2018 the club was successful with a grant application of \$1,798.00 from the Department of Health and Human Services as part of the 2017 - 2018 Sports Grants Program Round 2 for the development and improvement of club operations and their functioning. In season 2019 the club deployed this grant and appointed Terry Dillon Solutions to undertaken a review process via survey to generate a "Club Health Report". The results of this survey were published in a report back to the club where our WJFC June committee meeting was then dedicated to a workshop reviewing the content of the club health report and strategizing the opportunities the report / workshop revealed.

The WJFC health check reported overall at 60%. The report was assembled based upon the

confidential and independent survey of all committee members seeking assessment of the effectiveness of the club in prescribed areas of:

- > Committee Structure
- > Governance
- > Finance
- >Membership
- > Capital Grants
- >Digital Presence
- > Volunteer support
- > Sponsorship
- > Fund Raising / Fund Saving
- > And, taking the club to the next level.

The report result of 60% was benchmarked by Terry Dillon during the workshop and placed WJFC at the sharp end of the health spectrum as opposed to the 100's of clubs he had assessed using the same survey tools. WJFC gained strongest results in finance / Governance / Committee Structure, whereas the greatest opportunity for improvement was found in the areas of Volunteer Support, Fund Raising and securing Capital Grants.

This report is an excellent tool to underpin club planning for coming years and associated future committees.

These 3 items are the key outtakes in the 2018 report flagged for 2019 opportunity. The remaining 4 items flagged in 2018 included further grant applications, improved financial policies / disciplines / streamlining, review of the traditional August / August financial year and progressing our successful application to Microsoft 365 - Not for Profit - assistance.

Per enclosed results and improvement quality of reporting, that area of policy and discipline has progressed well. Expense is better managed and approval methods more transparent including a mandated NAB 2 party approval process for any payment / expenditure.

Grant opportunities were assessed during the year however no formal applications were made. Part of the clubs thinking here was to ensure we expensed the first grant effectively per above, and prior to seeking future funds. This will continue to be an area of focus in 2020 and all viable grant opportunities will be assessed.

The adjustment of the traditional financial year continues to be a work in progress.

Unfortunately the committee was not able to pursue the Microsoft 365 opportunity in season 2019. Limited committee resources did not stretch to allowing this initiative to be progressed. Hopefully additional interest in the 2020 WJFC committee will transpire into ownership of this opportunity.

#### Season 2019 - new initiatives.

The financial management mindset for season 2019 and subsequent new initiatives has been significantly influenced by the long anticipated prospect of upgrading our antiquated Bayside facilities.

Equipped with a growing appreciation the City of Hobson's Bay would be pressing the green light for our facilities upgrade, the committee has been mindful of the importance of building a financial reserve to service the predictable club commitments the new facilities will reveal. I acknowledge this mindset was established well before my time and the slowly accumulated cash reserves are a testament to those efforts past and present.

The club has in a practical sense looked to strengthen our position in 2019 via a combined approach

of better expense management (both identification and minimisation) as well as growing our income base in the areas of greater opportunity – which are those not affiliated with core WRFL fees. New facilities for season 2020:

After many years' effort and application across numerous committees past and present, we are on the precipice of something wonderful for WJFC.

Across the season the WJFC committee has been regularly engaging with HBCC and in later stages their nominated architect developing the best possible facilities upgrade within the confines of time and budget. HBCC have been very responsive to the input of WJFC and accommodated a large proportion of what was a "concept revision" put forward by the club mid this season.

The current status is the club has now formally vacated the existing change rooms, stored our memorabilia and we understand HBCC will appoint the builder in November 2019, with works indicated to commence this side of Christmas. The construction program we are advised shows works should be complete in the early part of season 2020 – so April / May at this stage.

#### Club apparel - online sales channel.

As is often referenced, WJFC has a strong reliance on volunteer input to manage many aspects of the club. Traditionally the club has sold its apparel range both preseason and during the season from the Bayside pavilion. This entailed holding significant stock levels on site and relies on volunteers to manage sales on game days. It has become very difficult to get volunteer input to assist with this process.

In season 2019 apparel sales have been managed through an online platform with long term supplier Primary Edge Promotions. Mel McVeigh invested significant time to set up this arrangement. This new approach would appear to have proven effective, which includes options for apparel to be collected from the club or delivered directly to the purchaser. The club receives a detailed monthly report of apparel sales and associated funds accordingly. This initial platform represented a one off investment of \$1,000 to develop. There are no ongoing charges.

The club resolved to undertake a stock assessment as part of this revised apparel arrangement. The enclosed financial results include a write down of \$20,624 of apparel stock value. This represents many years of accumulated apparel that is either outdated or has proven a poor selection and difficult to shift. This product will be part of free issue initiatives in season 2020 and / or form part of other membership initiatives or possible heavily discounted sales events.

Watch this space.

#### Sponsorship growth and development.

The club has grown sponsorship revenue in season 2019 by a little over 20%. Per recognition afforded in the president's report, the club has compiled a base of 12 sponsors across categories of Major Sponsorship (5), club apparel & equipment partners / sponsors (2), General club sponsors / partners (4) and a midvear event sponsor (1).

The WJFC sponsorship revenue channel of circa \$32,000 in season 2019 is a new benchmark for the

The above is the outcome of a greater focus by the club executive with both existing and new sponsors. This culminated in a sponsor's dinner held by the club to bring all sponsors together recognising their generous support of the club and building their investment in our vision and future

#### plans.

This will be a continued focus for season 2020 as we look to build our sponsorship base to \$50,000 in the next 3 years.

#### Club Social calendar and events.

Similar to commentary insofar as apparel management and sales are concerned, the social aspect of the WJFC is also heavily reliant upon the tireless efforts of volunteers, whom have done a wonderful job in season 2019.

This year the club made a conscious effort to adjust our social calendar mix mindful of (1) the competing social demands of our membership and avoiding oversaturation, (2) less events with more focus and diversity and (3) a conscious shift away from financial dependence on our key social events to bring / build funds for the club.

Season 2019 saw much greater emphasis and investment directed to the Season Launch day that was co-hosted with both Williamstown CYMS and Williamstown VFL. This event has no aligned revenue channel but has and will be further develop in a feature day where we can showcase our club, our sponsors and the overall Williamstown Football Community. In 2019 we invested almost \$4000 into this event.

Feedback was very positive from members, our football partners and sponsors alike.

Our Mid-Year main event showcased this new approach via a new venue and revised more casual format that seemed popular and well received by the circa 200 members that attended the evening at Williamstown Italian Social Club. Consistent with commentary above however, the late run on ticket sales did generate some worrying moments per the financial viability of the event. The lower cost base of the event ensured the event was favourable to the club in 2019 to the tune of circa \$5,000, heavily and gratefully underpinned by the many generous auction items donated on the

Season 2020 with the advent of our new club rooms and social space will throw a welcome whole new aspect into our social calendar options moving forward.

#### 2019 accounts:

#### 2019 accounts summary – revenue:

From the outset I flag the WJFC as stipulated by its constitution runs a financial period 1 September - 31 August. There is an ongoing misalignment between our genuine season activities that conclude at the annual AGM in October each year and the generated financial results that conclude August 31 as a consequence.

Income such as late sponsorship revenue (very minimal in 2019) and late expenses such as 2nd instalments of power / lighting, ground rent etc are consistently captured in the following financial year also as a consequence.

The club is serviced by 6 core revenue streams. Each is summarised in season 2019 as follows:

#### WRFL Registration fees.

Fees paid to the WRFL by the WJFC membership, as announced at the annual AGM, are subsequently redirected to the club less a \$12.50 administration fee per player. WJFC uses these funds to pay for WRFL services across the year including insurance, umpires fees, individual age group team affiliation fees (7 sets in 2019) an overall club affiliation fee - as well as other miscellaneous items.

In season 2019 WJFC received \$88,842.00 (2018 \$96,670.00) in fees and incurred \$36,877.00 (2018 \$39,577.00) in WRFL charges.

The decrease in fees of circa 8.8% relates to team number adjustments attributable to the 2019 Season "evens" age group structure where WJFC does not participate in the U18 age group (whereas we did in U17 2018). We also saw some refunding occur as age group numbers were resolved

Charges for WRFL services adjusted down proportionally accordingly.

#### **Apparel revenue:**

WJFC generated \$25,340.00 in apparel sales via our online shop as discussed elsewhere. Sales for the period last year were \$30,855.00.

The club purchases selected apparel items for resale as well as free issue items that are included in the annual membership fee paid. \$14,885.00 was invested in free issue apparel in 2019. This is the first year we have individually identified apparel costs commensurate with a status of resale or free issue.

As previously mentioned in 2019 as part a complete revisit of how we manage apparel moving forward, we have taken the decision to write down stock items that have been carried over for a number of years, to a zero value. That write down represents \$20,624.00.

#### **Canteen Sales:**

The WJFC canteen has performed strongly in season 2019 – credit to those who have volunteered their time during the year. This assistance has also made capturing the financial performance more reliable and accurate. Revenue over the year has increased by 31.5% from last year to \$24,110.00. The cost of operating the canteen in the same period increased by \$3,184.00 to \$16,333.00.

#### Club Sponsorships.

Refer previous commentary.

The increase in club sponsorship to \$31,901.00 for season 2019 is beneficially compounded by a lowering in associated costs. In season 2019 we did not need to commit to new ground and pop up signage. Hence sponsorship associated expenses in season 2019 were just short of \$2,500.00, as opposed \$5,374.00 last season.

#### Club events / functions.

Refer previous commentary.

The clubs income from this channel reduced substantially from \$32,973.00 last season to just short of \$18,000.00 this season. Consistent with the reduction in amount of events, as well as our added investment in the non-revenue generating Season Opening Day, our surplus from these activities dropped from \$8,366.00 to \$1,376.00.

#### Other income items:

Items including rebates from coffee truck sales, interest received on our long term holdings and the

like generated just over \$5,000.00 for the club.

As noted previously the club did not secure any Grant funding in season 2019, we did expend the 2018 grant of \$1.798.00 on the above mentioned WJFC club health check and committee development workshop.

#### 2019 accounts summary – cost of football services:

Consistent with earlier commentary, WJFC has been able to manage down our costs of providing football services in season 2019.

A good part of this comes from the investments the club made in season 2018 that included significant upgrades to our football kit, trainer's kit and new jumpers for our female teams -\$17,768.00 in total. Consequently the club has only incurred \$4,888.00 in the current period. In season 2019 WJFC did not have to operate a separate 3rd ground (Newport Gardens) that has also avoided \$2,250.00 expense this season as a consequence.

In season 2018 the committee also invested funds to improve some of the most basic shortfalls in the current change rooms – including repainting and improved floor coverings. That one off cost of \$11,510.00 is not present in season 2019 results with the club rooms upgrade now finally imminent. The enclosed financial reports detail the various expenses the club incurs as part of delivering weekend football for 16 teams across the 2019 season. These reports are self-explanatory and don't require any added commentary from me

#### 2019 accounts summary - season end 2019 position:

WJFC has delivered an operational surplus after apparel write down of \$32,550.00. This compares favourably to 2018 season \$15,946.00, noting last year did include the one off expense of club room improvements. A more suitable comparable would be the pre that expensed activity (as WJFC does not own the rooms) which was \$27,096.00 in 2018.

Member's funds have grown from \$165,714.00 last year to \$198,265.00 at the conclusion of season 2019.

Club assets have grown to the same \$198,265.00 after writing back our apparel stocks as outlined above.

At the conclusion of season 2019 WJFC has zero liabilities (current nor non-current) to report as opposed \$22,169.00 in 2018.

WJFC investment account balance: \$87,891.00. WJFC Holding account balance: \$62,021.00 WJFC Operational account balance: \$15,695.00. All above are reported as at August 31, 2019.

#### Acknowledgements and thank you:

I would like to thank the committee for its guidance and assistance during season 2019.

Circumstances dictate that I am not in a position to continue on the WJFC execute in season 2020.

I suggest any party interested in the 2020 treasurer's role will find it streamlined, user friendly (as

best it can be) and well recorded. I will happily assist the settle in of our next treasurer. Working with the current committee has been extremely satisfying and our ship is expertly navigated by Mel McVeigh and her trusty lieutenant Mark Ryan. We are in very safe hands.

I would specifically like to acknowledge the efforts of Ross Vicino both as a long standing committee member and an outstanding contributor to our football club. Few people would appreciate the power of work Ross has personally invested in WJFC over many, many years. Our sons have travelled through the club together to this concluding 2019 season and it has been an absolute pleasure to share Ross's company, friendship, good grace and a common Essendon tragic affliction across those

Thank you and well done Ross – a great loss to our club.

## Notes to the Financial Statements For the year ended 31 August 2019

### **Note 1: Summary of Significant Accounting Policies**

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act . The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

#### (a) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

#### (b) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

#### (c) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### (d) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

#### (e) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the assets and liabilities statement are shown inclusive of GST.

### DIRECTOR OF COACHING REPORT

In season 2019 the WRFL made changes across the league with the implementation of double groups. These changes were made in the graded age groups with divisions of Under 12, 14 and 16's formed with up to five divisions within that age group and three teams being fielded for WJFC.

The year started early for the committee with the changes meaning so many other questions were raised around a grading policy and process and as we had to work on a grading policy, it often felt we were chasing our tails trying to firstly educate coaches on the new policy and make sure that parents and players understood the new grading format. Fortunately moving forward we will have more knowledge on how to manage player numbers will have a more solid grading process.

Again, the club organised a Preseason Academy leading into the Christmas break and returned in Mid-January. For a second year running Mark Williams was instrumental in its application with appointed coaches Kristen Daly and Matt Wynd also playing a huge role. I would like to mention there was lots of help on offer due to the larger number of attendees at these training nights and thank all involved. After sitting through several Coaching appointments as a club we recognise the solid support from our parenting group at under 9 and 10, with those age groups filling very early in 2019. There was a strong showing for most of the higher divisions, but with the uncertainty of grading potentially playing a part, a shortage in other divisions. All in all, these positions were filled with great people within our club who have done an amazing job in their respective teams.

Early in February we, as a coaching group had the pleasure of a presentation by Anthony Eames, Senior Coach of Spotswood and Liston Medal winner in 1991 for Werribee. We also had a coach's night explaining what type of features this program would provide and a brief outline of its working of which was well received.

In closing, I truly believe a program of sorts to help coaches streamline their coaching would be extremely beneficial. With my decision to step down from this role to focus on coaching . I am sure the club will appoint a suitable candidate for this role. Thanks to all for the opportunity to give back to the club this year.
