



VICE PRESIDENT - FOOTBALL OPERATIONS REPORT

Dear WJFC Family,

After a "Season like no other", my head still spins simply trying to process and articulate the myriad of experiences and challenges we encountered along the journey this year!

After the unfortunate cancellation of the 2020 Season due to Covid-19, we were faced with the enormous challenge of re-booting the Club after waking it from Covid slumber - and were immediately spurred on by our passionate WJFC Community - keen to get back to normality as quickly as possible and equally eager to return to playing the "greatest game in the world!"

An extraordinary amount of work was undertaken over the Summer months to prepare for the 2021 Season - including the following:

- Creating a dedicated Football Operations Team (consisting of Jas Coghlan and Paul Winter) who ably assisted interviewing and identifying Coaches, planning a Covid friendly Roadmap to conduct Preseason training, provide major input into the newly created "Willy Way" Football Development Program - as well as unwavering "behind the scenes" support during challenging times throughout the Season.
- Identifying where all the existing Coaches equipment was (due to our Clubrooms being freshly rebuilt) and what condition they were in after such a long break. As a result, there was a significant investment/spend within the Football Department with key equipment purchases including new footballs, football bags, cones and stands, player bibs and whiteboard kits for all of our Coaches. Due to natural wear and tear over the journey we also identified the need to immediately manufacture and replace 6 of our existing Teams sets of jumpers with a view of replacing the remaining Team sets for the following 2022 Season.
- Working closely with Registration Gurus (Carly Pasco and Mel D) to manage and massage
 the registrations as they flowed in whilst providing careful consideration and ongoing
 monitoring to ensure all of our 2021 Teams were well balanced and manageable from a
 coaching perspective.
- Liaising with Steve McMahon to identify and negotiate the best possible outcome to access
 grounds for both Pre-Season and 2021 Season training and Games. I was particularly
 proud of how well our Coaches (and WJFC families) handled and adapted to the ongoing
 challenges around fluid training changes during the pre-Season and it certainly (and
 unknowingly at the time) prepared us for the stop-start nature of the Season ahead.

By the end of March - we were delighted to gain access to our shiny new Clubrooms for the first time and took this opportunity to host the inaugural SUPER SUNDAY which saw all 17 of our Teams take on neighbouring Newport Power FC which was a great day to not only showcase our new facilities but to celebrate the much-loved return of football within our local community.

Registrations

The total registrations for Season 2021 were 381 comprising of 17 teams spanning across the U9 – U16 age groups. With our welcome addition of Auskick for its first season, we had 222 registrations across Kindergarten to Grade 2+. Once again, many age groups had to be closed off before pre-season training commenced due to overwhelming demand. We still continued to receive registration enquiries right up until our last round. Our girl's enrolments remained consistent with 78 registrations (up from 74 in 2020) and our 3 dedicated girls' only teams in U12, U14 & U16 at capacity numbers. We look forward to fielding an U18.5 girls' team next season. I sincerely thank Carly Pasco for her role as registrar this year, her organisation and competence were second to none.

Canteen

We welcomed Lorraine our new Canteen Manager this year. After a 10-year tenure by the wonderful Julie-Anne there was a lot to learn by us newbies. Luckily Julie-Anne popped in to show us some trade secrets and then we were able to find our weekly groove. TREASURER'S REPORT

Financial Result

For Season 2021, the Club reported a Net Income of \$26,150, with Income of \$206,006 & Expense of \$179,856, with a detailed breakdown of both Income & Expense in the financial statements as at 31/08/21.

The final Net Income of \$26,150 was in line with expectations & was a pleasing result, given the cancellation of games in the later part of the Season impacted Canteen sales / profit & COVID restrictions meant that some planned Events could not proceed.

Balance Sheet

The fore mentioned Net Income for Season 2021 of \$26,150, together with inclusion of the Net Assets of Williamstown Auskick (refer below) of \$9,303 has increased the Net Assets of the Club from \$272,319 as at 31 August 2020 to \$307,771 as at 31 August 2021.

Furthermore, as at 31 August 2021, Cash Assets stood at \$168,697 versus Cash Assets as at 31 August 2020 of \$157,317, with the increase of \$11,380 partly due to the inclusion of Auskick's cash balance as at 31/08/21 of \$8,394

Given the above, the Club continues to be in a strong financial position.

Utilisation of Current Cash Reserves

The Club's Cash Reserves as at 31/08/21 shall be used to:

- 1. Limit the increase in Registration Fees for Season 2022 (which will now attract GST) to just \$10, & to keep the early Bird discount at \$50 (as was increased from \$20 to \$50 for Season 2021)
- 2. Finalise the fit out of the new Clubrooms
- 3. Pay for new Coaches Boxes for Season 2022
- 4. Further operational spend, to provide for an overall better playing experience (as was commenced in Season 2021)
- 5. Pay the balance for the new electronic scoreboard of \$42,913 (refer below)
- 6. New team football jumpers for 10-11 Teams

Williamstown Auskick

At the start of Season 2021, WJFC assumed responsibility for the ongoing operation of Williamstown Auskick, with Williamstown Auskick being run by a Sub Committee led by Jess Densley & well supported by Auskick's Treasurer, Nicole McCann. During Season 2021, Williamstown Auskick incurred a loss of \$909, reducing their cash at bank balance to \$8,394, which is now reflected in the financial statements of WJFC as at 31 August 2021.



TREASURER'S REPORT (cont)

GST Registration

During the year, & with the Club's income exceeding \$150,000, the Club registered for GST (as required by the ATO). The GST registration took effect from 1 August 2021, & going forward we will have to remit any net GST payable to the ATO on a quarterly basis. From 1 August 2021, all income will be subject to GST but this will be offset by the fact that we will now be able to claim input tax

credits for the GST component of our purchases. Overall, the financial impact of now being registered for GST is expected to be minimal.

Electronic Scoreboard

In March 2021, WJFC signed an Order with Electronic Scoreboards Australia for the purchase of a 3840mm x 2880mm electronic scoreboard for \$53,641 (GST inclusive) & paid a 20% deposit of \$10,728 (GST inclusive), with the deposit shown as a Current Asset in the WJFC financials as at 31/08/21. At the time of making the deposit payment, we were hopeful of securing the required approval of Hobsons Bay City Council shortly thereafter & thus paying the 80% balance (of \$42,913) & having the scoreboard installed & operational during Season 2021. Unfortunately, we are still yet to receive approval from Hobsons Bay City Council but hopefully we can secure this soon & then arrange for the scoreboard to be fully operational prior to the start of season 2022. The balance payment of \$42,913 will be funded from existing Cash Reserves.

Governance

I note that in Season 2021, the club continued to have in place & abide by a strong governance framework, with key examples being:

- 1. Every payment from a WJFC bank account must be authorised by at least two Executive Committee Members, being myself as Treasurer & Mel McVeigh as President or Mick Russell as Vice President
- 2. Monthly Committee Meetings, which are well documented & include a Treasurer's Report which shows the YTD financial results of the Club, with pertinent commentary
- 3. The annual financial statements of WJFC are compiled & audited by our current external accountants, Tripolino Accountants.

In Closing, I would like to note that it has been a pleasure being the Treasurer of the WJFC over the last 12 months & I acknowledge & thank the great work of many (the Executive Committee, Committee members, parents & players) to make Season 2021 the success that it was, under trying conditions.

Note 1: Summary of Significant Accounting Policies

Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of Victoria. In the opinion of the committee the association is not a reporting entity because it is not reasonable to expect the existence of users who rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The financial report has been prepared in accordance with the Associations Incorporations Act of Victoria, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031: Materiality and AASB 1054: Australian Additional Disclosures.

The association has concluded that the requirements set out in AASB 10 and AASB 128 are not applicable as the initial assessment on its interests in other entities indicated that it does not have any subsidiaries, associates or joint ventures. Hence, the financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Accounts Receivables and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Notes to the Financial Statements For the year ended 31 August 2021

(b) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

(c) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(e) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

The association has applied AASB 15: Revenue from Contracts with Customers (AASB 15) and AASB 1058: Income of Not-for-Profit Entities (AASB 1058) using the cumulative effective method of initially applying AASB 15 and AASB 1058 as an adjustment to the opening balance of equity at 1 July 2019. Therefore, the comparative information has not been restated and continues to be presented under AASB 118: Revenue and AASB 1004: Contributions.

In the current year

Contributed Assets

The association receives assets from the government and other parties for nil or nominal consideration in order to further its objectives. These assets are recognised in accordance with the recognition requirements of other applicable accounting standards (eg. AASB 9, AASB 16, AASB 116 and AASB 138).

On initial recognition of an asset, the association recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer).

Notes to the Financial Statements For the year ended 31 August 2021

The association recognises income immediately in profit or loss as the difference between initial carrying amount of the asset and the related amount.

Operating Grants, Donations and Bequests

When the association receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the association:

- identifies each performance obligation relating to the grant
- recognises a contract liability for its obligations under the agreement
- recognises revenue as it satisfies its performance obligations.

Where the contract is not enforceable or does not have sufficiently specific performance obligations, the association:

- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (eg. AASB 9, AASB 16, AASB 116 and AASB 138)
- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract liability is recognised as a related amount above, the association recognises income in profit or loss when or as it satisfies its obligations under the contract.

Capital Grant

When the association receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The association recognises income in profit or loss when or as the association satisfies its obligations under the terms of the grant.

Interest Income

Interest revenue is recognised using the effective interest rate method.

Dividend Income

The association recognises dividends in profit or loss only when the right to receive payment of the dividend is established.

Income from Sale of Goods

Notes to the Financial Statements For the year ended 31 August 2021

The association publishes and sells books and magazines publications to the general public. Revenue is recognised when control of the products has transferred to the customer. For such transactions, this is when the products are delivered to the customers. Volume discounts could be provided with the sale of these items, depending on the volume of aggregate sales made to eligible customers over every six-month period. Revenue from these sales is based on the price stipulated in the contract, net of the estimated volume discounts. The volume discounts are estimated using historical experience and applying the expected value method. Revenue is then only recognised to the extent that there is a high probability that a significant reversal of revenue will not occur. Where there is expected volume discounts payable to the customers for sales made until the end of the reporting period, a contract liability is recognised.

A receivable will be recognised when the goods are delivered. The association's right to consideration is deemed unconditional at this time as only the passage of time is required before payment of that consideration is due. There is no significant financing component because sales (which include those with volume discounts) are made within a credit term of 30 to 45 days.

Customers have a right to return products within 60 days as stipulated in the current contract terms. At the point of sale, a refund liability is recognised based on an estimate of the products expected to be returned, with a corresponding adjustment to revenue for these products.

Consistent with the recognition of the refund liability, the association further has a right to recover the product when customers exercise their right of return so consequently the company recognises a right to returned goods asset and a corresponding adjustment is made to cost of sales.

Historical experience of product returns is used to estimate of the number of returns on a portfolio level, using the expected value method. It is considered highly probable that significant reversal in the cumulative revenue will not occur given the consistency in the rate of return presented in the historical information.

All revenue is stated net of the amount of goods and services tax (GST).

In the comparative period

Non-reciprocal grant revenue was recognised in profit or loss when the association obtained control of the grant and it was probable that the economic benefits gained from the grant would flow to the entity and the amount of the grant could be measured reliably.

If conditions were attached to the grant which must be satisfied before the association was eligible to receive the contribution, the recognition of the grant as revenue was deferred until those conditions were satisfied.

When grant revenue was received whereby the association incurred an obligation to deliver economic value directly back to the contributor, this was considered a reciprocal transaction and the grant revenue was recognised in the statement of financial position as a liability until the service had been delivered to the contributor; otherwise the grant was recognised as income on receipt.

The association received non-reciprocal contributions of assets from the government and other parties for no or nominal value.

Notes to the Financial Statements For the year ended 31 August 2021

These assets were recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of profit or loss and other comprehensive income.

Donations and bequests were recognised as revenue when received.

Interest revenue was recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Dividend revenue was recognised when the right to receive a dividend had been established.

Rental income from operating leases was recognised on a straight-line basis over the term of the relevant leases.

Revenue from the rendering of a service was recognised upon the delivery of the service to the customer.

(f) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Note 2: Deposit - scoreboard

During the financial year, the Club signed an Order for the purchase of an electronic scroreboard to the value of \$53,641, and paid a 20% deposit, of \$10,728. Upon receipt of Council approval, the Club will move to pay the balance of the Order, of \$42,913, and arrange for the scoreboard to be delivered and installed.
